EMPLOYABILITY WEEK WORK PLACEMENT PARENTAL CONSENT

Work experience is a opportunity open to Year 10 pupils for the week of **15th July 2018**

This is an opportunity for students to spend some time with an employer, allowing them to experience, as far as possible, the hours, working conditions and regulations they may encounter when they enter the world of work. Students are expected to organise their own high quality placement, however we work with an external client to carry out Health & Safety checks and feasibility studies to ensure the provider offers the best experience for all students.

NO PUPIL WILL BE ALLOWED TO PARTICIPATE IN A WORK EXPERIENCE DURING TERM TIME UNLESS THE PROVIDER HAS BEEN VETTED BY FUTUREWORKS AND WE HAVE RECEIVED, PROCESSED AND COMPLETED ALL APPROPRIATE PAPERWORK.

STUDENTS WILL RECEIVE NOTIFICATION IF THEIR PROPOSED WORK EXPERIENCE HAS BEEN ACCEPTED OR DECLINED DUE TO HEALTH AND SAFETY ISSUES.

Parents play an important part in Work Experience. The areas you may be able to help in are:

- Parents offering work experience placements at their organisation or place of work
- Help their child with ideas or contacts for pupils to arrange their own placement
- Stress the importance of Work Experience
- Remind your child of deadlines set for paperwork

If your child wishes to participate, they **must arrange their own work placement** and complete and return the **Personal Placement Form** (available on the school website

Completed Forms to be returned to school before 11th January 2018

PLACEMENTS CANNOT BE PROCESSED AFTER THIS DATE

PLEASE NOTE: This deadline is **non-negotiable** and is in place to ensure all Vetting and Health and Safety checks have been undertaken prior to the placement. All forms **MUST** be returned to **Mrs G Mason** in school.



It is important to remember that:

- A placement usually lasts for one week
- No payment of wages is made by the employer
- Pupils are responsible for their own travel arrangements
- Pupils usually have to provide their own lunches
- Students hours of work can be arranged with the employer between the hours of 8am – 5.30pm Monday to Friday
- Placements depend on the goodwill of employers
- On placement, pupils are covered by the employers insurance policies
- It costs school £10.00 per placement so attendance is imperative
- Any alterations to placements now cost school **£10.00 per alteration**

PLEASE NOTE

The school reserves the right to remove any pupil from the activity at any time if the attitude and behaviour of that pupil does not come up to the high expectations of this school. We monitor student behaviour and achievement very closely using a points system and this will be used to decide if a pupil can attend a trip, visit or work placement.
